T. Herriott gave a summary of the RoofTop Ridge 2020 StateMap project in the North Slope, funded at \$165.9K. Described the challenges of summer fieldwork, as a result the global pandemic, and a potential plan for continuing to map the North Slope in 2021 – 2023.

Jamie Jones asked if DGGS had received any guidance from the **1:53 pm** USGS/StateMap coordinators. T. Herriot replied that in initial conversations, the USGS were very accommodating and a formal written document soon followed. S. Masterman stated he and Ken Papp had a promising meeting with Darcy McPhee – StateMap Coordinator, and that options are plenty. Ken Papp followed up by stating it's possible to request 6 to 9-month extension, the USGS has five years to close out the awards. The USGS must send out rewards for the current fiscal year.

M. Werdon presented a summary of the Mineral resources section's EarthMRI mapping project and airborne geophysics plans in the Yukon Tanana Uplands.

Werdon replied that DGGS is considering a reduced FFY20 project, due to the uncertainty of associated state CIP funding. M. Werdon summarized last summer's fieldwork in the eastern Tanacross area and stated the EarthMRI project also includes geochemistry re-analysis.
